- i. To meet at frequent intervals or at least once in three months to monitor the implementation of the project and lend necessary support at various levels.
- ii. To ensure that the Census Operations and the mandate of the UIDAI are synchronized with a view to achieve success for both the projects.
- iii. To put in place system for monitoring the collection of details of National Population Register through the State Government officials as well as a team of officers of the UIDAI.
- iv. Any other matter as decided by the Chairman from time to time.
