**ORDER:**

2. The Committee shall review the infrastructure gaps in developed and developing IT Clusters across the State. The Committee shall act towards resolving the identified issues at the earliest and ensure seamless operations of IT Industry in the State.

3. The Committee shall commission studies to identify shortcomings, improve IT infrastructure and suggest the best practices.

4. The IT Coordination Committee shall act as a single window for reviewing, redressing complaints and requests pertaining to IT infrastructure and any Government decision impacting the IT industry. Any issue/inconvenience faced by the Industry with regard to Infrastructure can be raised to the IT Coordination Committee.
