ORDER:

In the reference read above, the Managing Director, Telangana State Technology Services Limited (TSTSL), Hyderabad has stated that, the UIDAI provides API's to Authentication of Aadhaar and the APIs are only accessible through the empanelled Authentication Service Agency (ASA). The ASAs are entities to have secured leased line connectivity with the Central Identities Data Repository (CIDR) and presently many Government Departments of Telangana are using the services of CGG/NIC/MeeSeva for these AUA/eKYC Services. Further the Managing Director, TSTSL, Hyderabad has stated that, MeeSeva this being not an priority area, has expressed limitations in providing these services. NIC will provides these services only, where the application is also maintained by them as a result of which few Departments have access and the CGG was providing this facility for many Departments, but have stopped these services recently.

2. The Managing Director, TSTSL, Hyderabad has further stated that, the Board of Directors of TSTSL, Hyderabad have decided that, TSTSL should provide range of Authentication and eKYC services in Web, Windows, Android and Linux platforms along with the required SDK's/API's/DLL's for integrating to any existing applications of any Department/Organization of Government of Telangana and the services shall be state through a robust, scalable, protected by taking connectivity from different ASAs, for interrupted flow in the services as detailed below:

TSTSL AUA/eKYC services be used

- a. for eKYC and Authentication
- b. TSTSL as an AUA can provide Aadhaar Services to any Department/Organization under Government of Telangana to uniquely identify an Indian Resident.
- c. TSTSL can implement Aadhaar based Attendance System to all Departments/Organizations / Corporations under the Government of Telangana like

TSTSL AUA/eKYC services be used by many Departments including

- 1) Civil Supplies
- 2) Panchayat Raj & Rural Development
- 3) CCLA for Land Records
- 4) Stamp Duties & Registrations
- 5) Commissioner ESD MeeSeva
- 6) Revenue Department
- 7) Agriculture Department
- 8) Social Welfare Department
- 9) Department of School Education/ Intermediate Education/Higher Education/ Technical Education.

3. Further, he stated that, the TSTSL has identified a Service Provider and the charges shall be comparable to the market rates charged by others and requested the Government to appoint the TSTSL as Authorized User Agency (AUA) for providing AUA/eKYC services relating to Aadhaar, mandating all the State Government Departments /Corporations to use TSTSL services for Authentication and eKYC.

4. Government after carefully examination, the proposal of the Managing Director, TSTSL, Hyderabad is considered and the "Telangana State Technology Services Limited" is hereby appointed as Authorized User Agency (AUA) for providing AUA/eKYC services relating to Aadhaar.
